



## Dennis J. "Denny" Mick

July 20, 1941 - June 26, 2010

Dennis J. "Denny" Mick, age 68, of Huntington, died at 8:50 p.m. Saturday (June 26, 2010) at the Visiting Nurse and Hospice Home in Ft. Wayne.

Denny was born on July 20, 1941, in Huntington, the son of Ralph Mick and Annabel (Shroyer) Feigel. Denny was a member of the St. Mary's Catholic Church and loved to prepare food for the Open Door Organization with the church. On February 4, 1961, he married Donna Kastner in the Queen of Angles Catholic Church in Ft. Wayne.

Denny retired on December 31, 2008 from the Huntington County Plan Commission after working 18 years as building inspector. He also was a retired Huntington City Fireman from (1965 -1990). He served as Fire Chief for 6 years (1984-1990). He had worked for the Schmalzried Construction Company for over 20 years.

Survivors include his wife of 49 years – Donna Mick of Huntington; one son - Dennis Todd (Angie) Mick of Ft. Wayne; one daughter – Tiffany (Timothy) Albertson of Huntington; one brother – Kent J. (Judy) Mick of Roanoke; and six grandchildren.
